To participate in this Promotion you (hereinafter “you” or the “Participant”) need to register your interest in the new Xperia XZ2 on the EE website on the following page: shop.ee.co.uk/sony-xperia-competition by (i) providing your personal details including name, email address and phone number during the period between 09:00 26th February 2018 and 23:59 21st March 2018 (the “Promotion Period”) (an “Entry”). This Promotion is limited to one Entry per person via the shop.ee.co.uk/sony-xperia-competition.

3. Details of trip to Japan (the “Prize”) are as follows:

The Promoter will send the winner and a plus one to Japan to see meet Aibo at Sony Headquarters. The winner and one guest will also go on a Tokyo sightseeing tour with an English-speaking guide and transport including a 40-minute Sumida River cruise.
